MPFNL Incident Referral Form

Umpires in all grades of matches who wish to raise an incident from a match should now use the Incident Referral form. The link to this form is below.

The form shall be used in the following circumstances;

- 1. Where an incident has gone unobserved by umpires, eg, player felled behind play.
- 2. Where an incident has occurred and the officiating umpires habe not made a report but wish the matter to be reviewed by the MRO.

The form is not to be used for any matter that is raised by a club unless the umpires are aware of the said incident.

Reporting – procedural matters.

Please note that umpires should not be using external footage to clarify reportable offences. If umpires are unsure of the player that should be reported AFLSE has asked that you report the club and AFLSE will manage the rest.

Holding the Ball – calibration.

At Wednesday's coaching session, umpires viewed a number of holding the ball decisions. The aim of the session was to come to agreement on what we should be paying and what we should be calling play on/ball up. Please review the following examples;

Correct non holding the ball. The ruck rule has changed. Ruckman are entitled to take the ball from the ruck and be given a prior opportunity. In this case Pines has not had a prior opportunity and Xavier correctly calls for a ball up.

Correct Holding the Ball. Red Hill evades the first tackle and on the second is correctly tackled and does not dispose of the ball legitimately. Correct call by Eddo.

In this instance Sorrento has not made a genuine attempt to dispose of the ball. Ideally we would hold off on the whistle a fraction longer to provide a further opportunity, however we are comfortable with the call.

Chelsea has had a prior opportunity in this instance. Our cue is the evasion of the tackle (ball placed in the air). The ball is not disposed correctly and thus a correct call by Sam.

This is an unwarranted Holding the Ball. Edithvale picks the ball up and is not balanced and steady. He has only taken 1-2 steps, therefore the call should be play on.

Correct HTB against Frankston Bombers paid by Rohan. FB dives on the ball and fails to dispose of it immediately. Correct FK.

Correct non HTB. The Sorrento player picks up the ball, is not balanced and steady and therefore has not had prior.
